

NKC WAIVER

PARTICIPANT AGREEMENT, RELEASE, AND ASSUMPTION OF RISK

In consideration of the services of Boland Family Enterprises Inc., Naples Outfitters LLC, Naples Kayak Co. LLC, and Everglades Kayak Co. LLC, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "NKC"), I hereby agree to release, indemnify, and discharge NKCC, RRP REC Inc. dba Glades Haven, Park Shore Marina LLC, Village I Land and Trust, Commercial Management of Collier County, Akim Sergey Partners Inc dba Extreme Family Fun Spot, Rita's Italian Ice of Naples Inc, their members, employees, independent contractors, directors, officers, partners, shareholders, managers, management companies, agents, and affiliated companies (hereinafter collectively referred to as "The Property"), on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative, and estate as follows:

1. I acknowledge that kayaking, sea kayaking, canoeing, paddle boarding, and other outdoor activities entail known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

If I have chosen to use a spray skirt, I realize that this represents an increased risk of entrapment, injury, and/or death.

The risks include, among other things: boat capsize and entrapment; tidal conditions, surf, and currents; travel in remote areas; collision with objects or other watercraft; prolonged exposure to cold water, hypothermia; accidental drowning; illness in remote areas; exposure to sun, heat, strong wind, cold, storms, lightning, large waves, eddies, and whirlpools; aggressive and/or poisonous wildlife; wrist, arm, shoulder, and/or back injuries, including repetitive motion injuries; slips and falls while walking, getting in or out of kayaks from land or a dock; slip or fall while approaching or walking on a dock or beach; rapidly changing adverse weather and water conditions; and being lost.

Furthermore, NKCC employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings, instructions or directions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless NKCC and The Property from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of NKCC's equipment or facilities, including any such claims which allege negligent acts, negligence per se, or omissions of NKCC or The Property.

4. Should NKCC, The Property, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

6. In the event that I file a lawsuit against NKCC or The Property, I agree to do so solely in the state of Florida, and I further agree that the substantive law of Florida shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against NKCC and The Property on the basis of any claim from which I have released them herein. I understand also that the kayak(s), canoe(s), paddleboard(s), paddle(s), PFD(s), leash(es), roof kit, straps, and any other gear related to the tour, lesson, demo, or rental (hereinafter collectively referred to as "Equipment") has been rented to me and I **am solely and fully responsible for any use of the Equipment by any other persons. I also agree to pay full purchase price minus 20% for any and all damages or loss to the Equipment that I have rented. I agree to pay a minimum \$100 rescue fee in the event that I and/or the Equipment must be recovered by NKCC or The Property.**

I HAVE HAD SUFFICIENT OPPORTUNITY TO READ THIS ENTIRE AGREEMENT. I HAVE READ AND UNDERSTOOD IT, AND I AGREE TO BE BOUND BY ITS TERMS.
